# 2019 TXTA Technician of the Year

The Technician of the Year Contest recognizes the contributions of outstanding technicians of the heavy duty fleet maintenance industry. The contest evaluates the technician's knowledge of his/her trade and ability to utilize that knowledge on basic mechanical problems. **There is no fee to enter a Regional contest, however, contestants qualifying for the State Championships will be required to pay a \$50 registration fee and are expected to be sponsored by the company they represent or pay their own travel expenses. TXTA will not be responsible for any expenses.**

## **Eligibility:**

All interested parties residing in the state of Texas and/or employed by a Texas based company involved in truck fleet maintenance, will be allowed to compete.

## **Regional Competitions:**

There will be six regional competitions. The Regional Competitions will take place in San Antonio, Houston, Dallas, Fort Worth, Tyler, and Amarillo. A written test will be administered at each region. Based on test scores, **the top three (3) contestants** will advance to the state finals. Contestants are allowed to compete in only one Regional Competition.

**Regional Competitions will take place May 4, (Dallas, Ft. Worth, San Antonio, Amarillo, Tyler and Houston) as indicated below, beginning at 10:00 a.m. The written test in Tyler will begin at 8:30 a.m. If not on time, contestants will be disqualified.**

## **State Finals:**

The State Finals will be held in Waco, Texas, June 1, 2019, at the Texas State Technical College Campus. Testing at the State Finals will consist of a practical hands-on test covering a variety of mechanical problems.

## **Sponsors and Prizes:**
